Abstract: All animals need to coordinate their behavior with the temporal structure of the world around them. How we should explain this coordination is the focus of my dissertation. My dissertation has three main parts in which I address this question by bringing to bear the tools of philosophy and the cognitive sciences. First, I argue that a wide range of animals possess a genuine sensory system for time that provides them with information about the approximate time of day. While this sense of time is in many ways analogous to the paradigmatic senses, like vision and olfaction, it does not gather information through any causal interaction with the environment but rather depends on its own endogenous rhythms. Second, I argue that the perception of time is not a single psychological phenomenon, but is instead, fragmented. I then use the fragmentary model of temporal perception to undermine the central debate in the philosophical literature on temporal experience concerning the mirroring constraint. Finally, I argue that temporal information encoded in distinct systems is integrated through a process of unitization that parallels how we as a society have come to unitize the measurement of time.
